



Whether it's the creative midfielder or the ball playing defender, interaction with the ball is vital and the need for the perfect touch and pinpoint pass accuracy are key requirements for success. This player also covers greater distances and therefore comfort and durability are also key performance factors.

The Spring/Summer 2023 Tocco is the ultimate hybrid boot featuring both FSDX Dyneema Leather and microfibre on its upper. Dyneema enhances the players feel on the ball, allowing him/her to control the ball better. The microfibre to the rear quarter provides support and stability – key factors for excellent control of the ball.

#### FSDX Dyneema Leather

FSDX Dyneema Leather is a unique material which fuses the strength of Dyneema fibres with premium leather. This allows us to create a super strong but ultra thin, lightweight leather boot for a closer touch and enhanced feel on the ball.

#### Microfibre Rear Quarter

Synthetic microfibre rear quarters add support to the mid-foot securing the foot in place. This means that the foot will not slide within the boot and the player can have better control over his/her game.

#### Comfort Insock

The anatomical, low profile insock follows the contours of the foot for optimum comfort.

#### Pebax Powered Control+ Outsole

The dual-density Pebax Powered Control+ outsole features Wishbone technology. This dual density construction means that the levels of stiffness throughout the outsole can be controlled and deployed where needed. The unique Wishbone configuration provides rigidity in the rear and midfoot sections, whilst maintaining flexibility in the forefoot to deliver maximum energy return. This ensures the boot moves naturally with the foot.



Any provision of the Contract that expressly or by implication is intended to come into or continue in force on or after termination (including clauses 5.3 and 6 to 12) shall remain in full force and effect.

#### INDEMNITY
